#### **Minutes**

**Guest Speaker:** Christine Perkins, Regional Client Director and Rebecca Freedman, Co-Founder & SVP of Professional Development from First Day presented on "Building Responsive Classrooms from Day One". The program is integrative and not additive and provides systematic consistency. It inspires teachers to give children tools in building skills children need for problem solving. The program focuses on challenging behaviors, building body confidence, and satisfying sensory needs. To change any behaviors, we have to slow down. The Big Idea Reaction requires a thoughtful plan. They change behaviors by empowering teachers with the science of behavior change and equipping educators with knowledge and strategies.

Membership Dues Report: Deana Howell reported that since the report had been published UAMS had paid their dues so that the amount due should be subtracted by \$2320 leaving a balance due of \$1690. ## **New Business**

The Future of the AHSA/HSSCO: Jackie Govan reported that the Collaboration Director Position would be moving to the Office of Early Childhood when the current lease expires. Some options discussed were sharing space with another organization such as the Arkansas Community Action Agencies Association or closing out the office and working from home. The committee discussed other fundraising options such as a Walk-A-Thon during the week of Children's Week.

**Arkansas Early Childhood Commission Board Election:** Jackie Govan shared that Shirley Pulliam has been recommended to the Office of Early Child as the Head Start representative to the Arkansas Early Childhood Commission.

**Region VI Head Start Association Institute-2026:** Jackie Govan shared that Region VI had Arkansas down to host in 2026 but there is confusion about the schedule since we had ours in 2022.

**Head Start State Collaboration Office Refunding Application:** Jackie Govan provided an overview of the funding application that will be submitted to the Regional Office prior to December 1, 2024, and gave programs an opportunity to review the program narrative. It will be voted on at the Board Meeting.

**Head Start Final Rule:** Jackie Govan shared that there will be training coming out for programs by the Office of Hed Start that will share specific examples for comparing salaries.

## Reports

**Arkansas Early Childhood Commission (SAC):** Jackie Govan shared that they met in October and that she provided a written report due to a scheduling conflict. She tried to get a copy of the minutes, but they had not been completed at this time.

Arkansas Head Start-State Collaboration Office-Jackie Govan She shared that the Collab Office has sponsored several events based on the needs assessment. We will stop doing the Dads Reading on the Carpet due to low participation. The Fatherhood Mentoring in the high schools was very successful but ended due to Covid. We are having low turnout at the Early Head Start Child Care Partnership Meetings. She shared information on the Learns Act. There is now a local lead in all 75 counties. The School Readiness Summit focused on a triad with Head Start, Local Leads, and Arkansas Imagination Library. Jackie shared information on the Family Service Credential Training that will be held February-April 2025. The Child Development Early Learning Standards are being updated.

**Region VI Head Start Association:** Jackie Govan shared that they had filled vacancies in officer for the Region VI Board. She presented information about updating the Region VI Head Start Association Bylaws. The board is also working on updating their policies and procedures.

**Arkansas Head Start Association Institute:** Sara Wilhite shared that the focus will be on mininstitutes.

**National Head Start Association Updates:** Jackie Govan shared that the NHSA Board met in September but she did not attend. Tommy and Yasmina have been sharing information on what could happen based on the election.
